ADMINISTRATIVE ORDER

In accordance with CB 65-2009, the following case assignments are hereby entered as follows to-wit:

Effective immediately:

Judge Steven Parker shall hear all civil matters not otherwise specifically assigned to other judges and all guardianship matters other than those listed on attachment A;

Judge Richard Branam shall hear all criminal matters including juvenile delinquent cases;

Judge Rebecca Cryer shall hear all juvenile matters except juvenile delinquent cases. In addition, Judge Cryer shall hear all guardianship cases listed on attachment A.

Beginning June 20, 2016:

Judge Steven Parker shall hear all civil matters not otherwise specifically assigned to other judges and all adult guardianship matters;


Judge Richard Branam shall hear all criminal matters including juvenile delinquent cases;

Judge Cryer shall hear all minor guardianship and juvenile cases, except juvenile delinquent cases.

Where necessary, the Clerk of the Court shall issue Notice to any party of a change in the hearing date. The Clerk shall also furnish each District Court Judge a file stamped copy of this order.

In the event of an emergency requiring immediate attention to a matter and the assigned judge is unavailable, the Presiding Judge of the District Court is hereby authorized to appoint a replacement judge.
